Pacific Islands Trade with China 2019

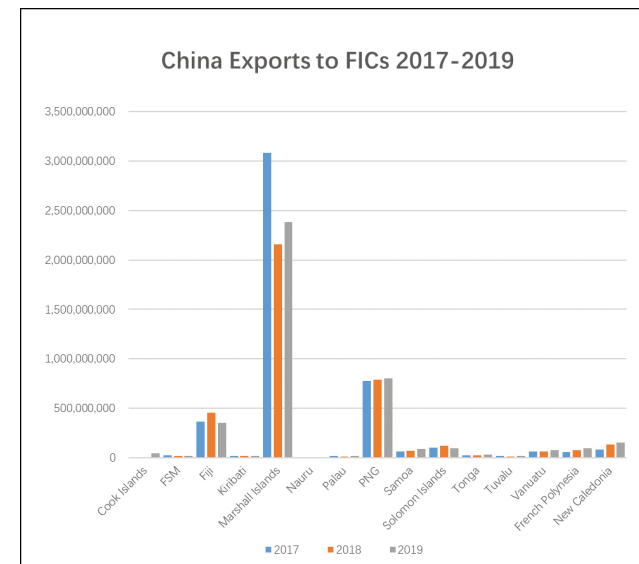
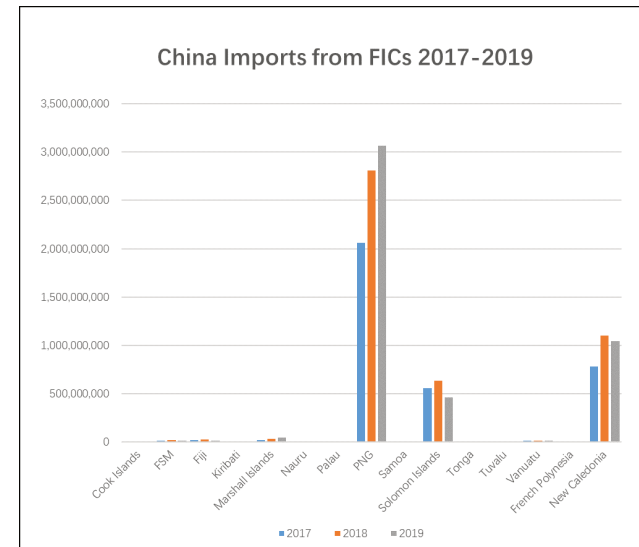
China's economy has enjoyed forty years of remarkable growth that has seen the country's thriving economy create a transformation of global patterns. China has now recorded the world's largest export value of merchandise while becoming a major importer is driving demand for internationally traded commodities from economies in the Asia Pacific region and beyond.

The world economic leader is now entering a period of a slower pace of sustainable and balanced growth that has resulted in a fast growing consumer market and at a speed not seen before. This renewed focus to control economic growth has proven that the country still exceeds the growth target set by the government of China.

China's strong consumer base and growth in technology and innovation has today advanced the country to become a leader in digital innovation with online channels rapid growth becoming the 'new retail'. China's consumer attitude is also evolving from a relatively price sensitive mindset to a more premium search behaviour. This transformation in China provides a significant step for Pacific Islands exports and tourism to develop strategies that reflect a this growing market and opportunities for high-end consumers in China.

In 2019, the value of trade in goods between the People's Republic of China and the Forum Island Countries (FICs) reached almost US\$9 billion comprising of exports from China to the FICs of just over US\$4 billion and exports from FIC's to China of almost US\$5 billion. This has demonstrated encouraging results in export growth when compared to the last two years and it is evident that there is increased business interests for Pacific businesses to access the China market. This projection of growth is therefore a step towards narrowing the trade deficit between China and FIC's.

Papua New Guinea, New Caledonia and the Solomon Islands have remained FIC's top three exporting countries with consistent growth of exports in minerals, nickel, iron and timber. There has been remarkable growth in fisheries exports from the Federated States of Micronesia, Kiribati and the Marshall Islands. New export industries have also been notable on the statistics namely skincare, essential oils and new beverages and juice from the Pacific. This is again testament of the ability of our Pacific exporters to supply not just commodity products but niche and value added health products and other goods that reflect the region's unique environment.

Pacific Trade Invest China promotes trade, investment and tourism opportunities for our sixteen Forum Island Countries and connecting export-ready and export capable businesses with Chinese buyers.

I do hope this handbook, with detailed statistical data on the trade between China and the each of our Forum Island Countries will help inform businesses, policy-makers and researchers and make a contribution to the identifying further opportunities to build two way trade and economic development.

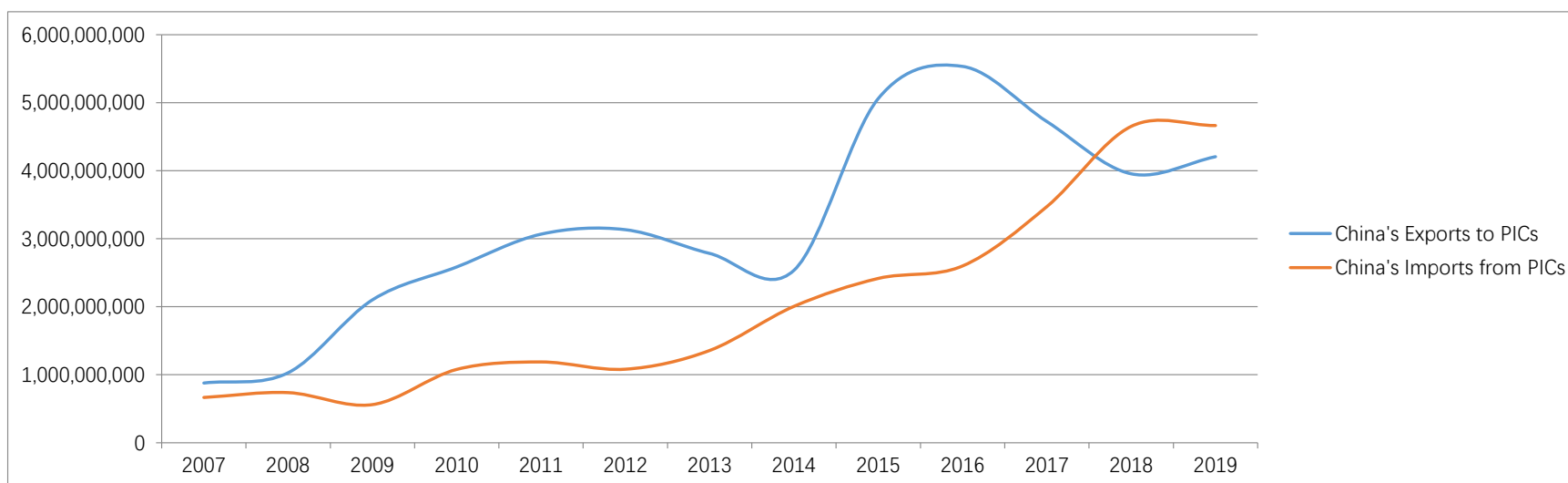
