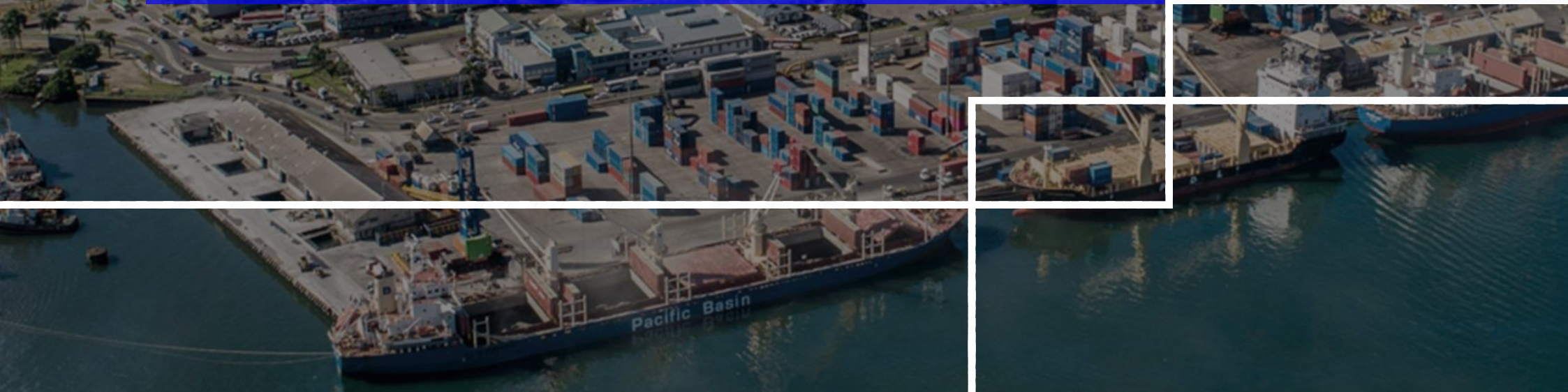

Pacific Islands Trade with China 2020

Pacific Trade Invest China is pleased to present the China-Pacific Islands Trade Statistics 2020. This marks the 8th year since the first release of the annual statistics handbook. The handbook is a compilation of statistics that provide the value of trade in goods across key industries and an analysis of key trends of trade between China and the 16 Pacific Island countries.

The year 2020 was a challenging one for the Pacific Region as the unprecedented threats to world trade from the outbreak of the COVID-19 pandemic threatened key drivers of economic growth across global business. Small and medium sized enterprises were affected as supply chains across key markets virtually came to a halt forcing production levels in the Pacific to scale back while the decline of international market demands continued to decrease. The tourism industry as a key economic driver in a number of Pacific countries also suffered heavy losses with travel bans, border closures and lockdowns in short haul tourism markets.

In 2020, the value of trade in goods between China and the Forum Island Countries (FIC's) was US\$8.99 comprising of exports from China to FIC's at US\$5.15 billion while exports from FIC's to China was at US\$3.84 billion. The statistics have shown a historic decrease in the total value of exports from the FIC's to China by 17% and the first in almost 10 years.

The three countries with the biggest decrease were PNG down by 25% mainly in fish, aquatic products, fossil fuel wood products, and minerals; Solomon Islands down by 23% mainly in ash, and wood products; Marshall Islands a significant decrease by 82.4% mainly in fish and other aquatic products.

It is worth mentioning that despite the overall export downturn, some Pacific island countries have generated an upward export trend with countries like Fiji with an increase of exports by 64% wood and wood products showing an almost 4-fold increase when compared to 2019. Tonga, with a steady agricultural export industry also saw an increase in the exports of edible vegetables, roots and tubers, at a growth of 241% of single products even during the global epidemic.

New Caledonia's mineral industry has continued to increase export value mainly in ore, slag and Ash by \$126m when compared to the export value of ore slag alone in 2019 showing an increase of 10%.

When analyzing the 2020 statistics, the impact of COVID-19 also posed significant challenges to seafood exports from the Pacific to China. China's adoption of stricter import inspection and quarantine requirements and the restrictions imposed on returning fishing crew from some of island countries also contributed to the decrease of seafood exports. Other export products like timber and some mineral products that China from some the Pacific countries also saw Chinese importers source from other key markets therefore a further contribution to this downward trend. of exports. In relation to agricultural exports, while China continues to grow its agricultural industry and with an interest to import, however there remains issues around volume and inconsistency of supplies throughout the year due to the impact of COVID-19. There also remain some countries with no market access in place yet for agricultural exporters to China.

From the perspective of importing Chinese products, 2020 is undoubtedly a special year. All countries have different levels of purchase demand for epidemic prevention materials. The total import of pharmaceutical products reached USD6.72 million; and the total export value from China to 16 Pacific member countries was US\$5.145 billion, an increase of 22% from 2019, which was also the largest increase over the last five years.

In addition to the analysis of the export data, PTI China has also provided data by individual FIC's. It is our hope that that the handbook will provide for exporters, importers, SME's and policy makers in both China and the Pacific Islands some insights in to the trade and economic trends of trade in goods to assist in forward planning, strategic directions and decision making in exploring business opportunities in the wake of COVID-19.

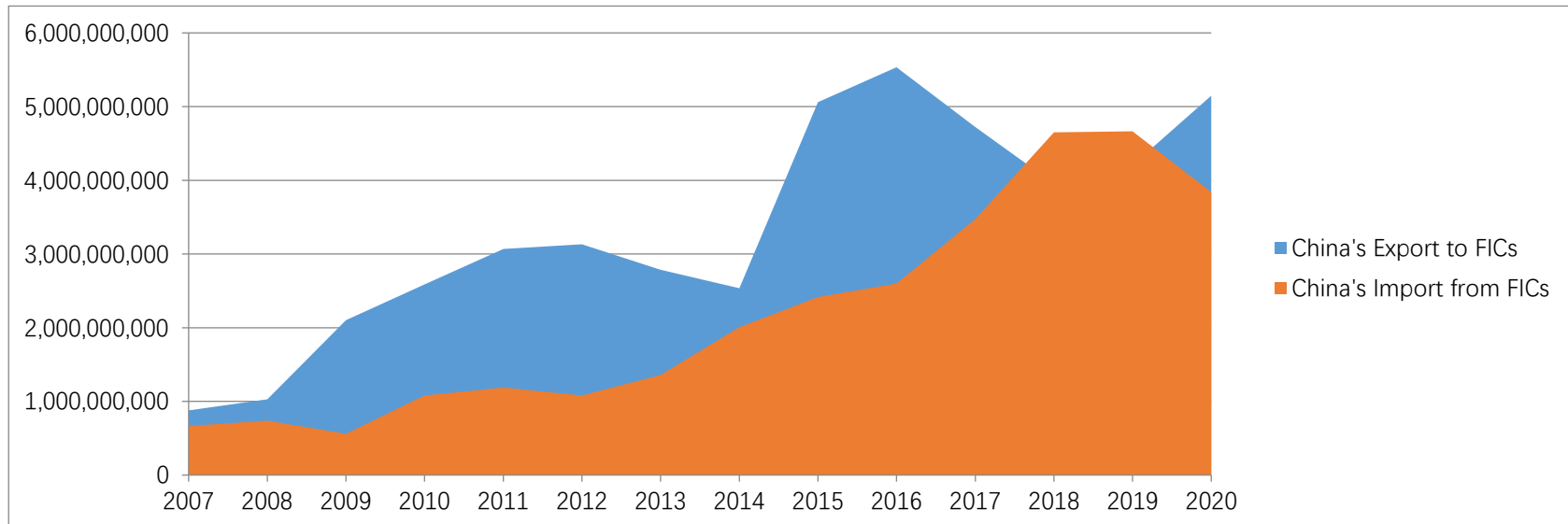
